

**ORDINANCE NO. 13-2023**

**AN ORDINANCE AMENDING ORDINANCE NO. 10-2023 TO MAKE  
APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES OF  
THE VILLAGE OF MARBLEHEAD, STATE OF OHIO, DURING THE FISCAL YEAR  
ENDING DECEMBER 31, 2023 TO DECREASE THE GENERAL FUND ALLOCATION  
FOR CEMETERY EXPENSES AND DECLARING AN EMERGENCY**

**WHEREAS**, on March 30, 2023 the Council of the Village of Marblehead adopted as an emergency measure Ordinance No. 1-2023 entitled "An Ordinance Setting Appropriations for Current Expenses and Other Expenditures of the Village of Marblehead, State of Ohio, During the Fiscal Year Ending December 31, 2023 and Declaring an Emergency; and

**WHEREAS**, on August 23, 2023 the Council of the Village of Marblehead adopted as an emergency measure Ordinance No. 10-2023 entitled "An Ordinance Amending Ordinance No. 1-2023 to Make Appropriations for Current Expenses and Other Expenditures of the Village of Marblehead, State of Ohio, During the Fiscal Year Ending December 31, 2023 to Increase the General Fund Allocations for Police, Street Lighting, and General Government Expenses and Declaring an Emergency; and

**WHEREAS**, there is a need to decrease amounts appropriated in the General Fund for Cemetery Expenditures to comply with an audit adjustment transferring \$300 from the General Fund to a newly created Cemetery Fund; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARBLEHEAD, OTTAWA COUNTY, STATE OF OHIO:**

SECTION 1. That Section 1 of Ordinance No. 10-2023 is hereby amended as follows:

That there be appropriated from the **GENERAL FUND**:




